** tariff is set for one consultancy or provision within 30 minutes. Rendering of a service in a time span less than 30 minutes is considered as one provision. The price is calculated based on the tariff used and the number of consultancies or provisions.

***VAT is applied according to the effective Tax Legislation.

**** If paying in Belarusian rubles, euro or Russian rubles, the amount of tariff is determined based on the tariff set in US dollars and the official exchange rate of the respective currencies set by the National Bank of the Republic of Belarus for the date of the invoice. The tariffs are rounded up according to arithmetical rules: in euro and Russian rubles, the sum rounds up to the nearest hundredth, in Belarusian rubles – to 100 Belarusian rubles if paying with bank notes of 2000 and up to the nearest hundredth if paying with bank notes of 2009.

***** Additional goods are goods with the same FEACN code, country of origin etc. but considered as separate item of goods in accordance with legislation of the Customs Union and the Republic of Belarus. It is applied if there are more than 10 items of goods in one Goods

Declaration, Declaration of Customs Value-1, Declaration, Declaration of Customs Value-2,
Correction of Customs Value.
